## *Cancellation Policy*

1. **Cancellation at Least 1 Month Before the Event:** Participants who cancel their registration at least one month prior to the event will receive a **70% refund** of their payment. IRunner will retain a **30% cancellation fee**.
2. **Cancellation Between 1 Month and 1 Week Before the Event:** Participants who cancel their registration within this time frame will receive a **50% refund** of their payment. IRunner will retain a **50% cancellation fee**.
3. **Cancellation Less Than 1 Week Before the Event:** Participants who cancel their registration within the final week before the event will receive a **15% refund** of their payment. IRunner will retain an **85% cancellation fee**.
4. **Registration Transfers:** Participants may transfer their registration to another individual up to one week before the event. This transfer is subject to IRunner approval.
5. **Cancellation by IRunner:** If IRunner cancels the retreat due to unforeseen circumstances, participants will receive a **full refund** of their payment or the option to reschedule for a future retreat.
